RESOLUTION 14-13

A RESOLUTION FIXING THE SALARIES AND WAGES OF FULL-TIME EMPLOYEES OF THE CITY OF ORRVILLE ELIGIBLE FOR MEMBERSHIP IN THE UNITED CITY WORKERS UNION (UCW) FOR THE GRADES HERETOFORE ESTABLISHED, REPEALING ALL LEGISLATION INCONSISTENT HEREWTH, AND DECLARING AN EMERGENCY.

BE IT RESOLVED by the Council of the City of Orrville, Ohio:

Section 11: A person whose current pay grade is higher than that provided for in this Resolution shall not receive a reduction in pay as a result of the adoption of this Resolution.

Section 12: That effective January 1, 2013, full-time employees who work second shift shall receive a shift differential of thirty (\$0.30) cents per hour and full-time employees who work third shift shall receive a shift differential of forty (\$0.40) cents per hour.

Section 13: All legislation inconsistent herewith is hereby repealed.


