RESOLUTION NO. 16-07

A RESOLUTION DECLARING THE NECESSITY OF CONSTRUCTING SIDEWALKS ON CERTAIN PROPERTIES IN THE CITY OF ORRVILLE.

WHEREAS, there has been an increase in pedestrian and vehicular traffic at the locations indicated herein as a result of development in those areas; and

WHEREAS, this City Council believes that sidewalks in newly developed areas are essential to the safety of pedestrians traveling therein.

NOW, THEREFORE, be it resolved by the Council of the City of Orrville, Ohio:

Section 1: That it is necessary to construct certain sidewalks at the following locations in the City of Orrville, Ohio:

- Back Massillon Road, north side, from Crown Hill Road to and including Lot 3304;
- Back Massillon Road, south side, from Crown Hill Road to Harvest Drive;
- Beaver Street, east and west sides, from Markley Avenue to southern terminus;
- Birch Street, east and west sides, from Oak Street to southern terminus;
- Buckeye Street, east and west sides, from Markley Avenue to southern terminus;
- W. Church Street, north and south sides, from Bell Avenue to Crown Hill Road;
- W. Church Street, north and south sides, from N. Sunset Drive to western terminus;
- W. High Street, north side, from Crown Hill Road to western corporation limits;
- W. High Street, south side, from N. Sunset Drive to corporation limits abutting Lot (6);
- N. Linden Avenue, east and west sides, Market Street to Lot 3083;
- S. Linden Avenue, east side, Market Street to Harding Avenue;
- W. Oak Street, north sides abutting Lots #1231, 1230, 1229, 1228 and 1227 and 1226;
- Sassafras Street, south side, from Main Street to eastern terminus;
- Sassafras Street, north and south sides, from Main Street to western terminus;
- Smucker Road, south side, from N. Crown Hill Road to Rohrer Road;
- S. Elm Street, west side from Wheeling & Lake Erie RR tracks to Schrock Road;
- S. Elm Street, east side, from Fike Avenue to Grove Lan;
- N. Sunset Drive, east and west sides from W. High Street to existing sidewalks abutting Lots 1937 and 1948;
- Wabash Avenue, east and west sides, from and including lots 1735 and 1013 south to Penn Avenue; and
- Willard Drive, north side, from N. Crown Hill Road to and including lot 2646.

Section 2: The plans, specifications and estimate of cost for the construction now on file in the office of the Clerk of Council of the City of Orrville, Ohio, are approved.

Section 3: The owners of each lot and parcel of land bounding and abutting on the proposed sidewalks shall construct that portion of the sidewalks that abut their respective properties, in

accordance with the plans and specifications filed in the office of the Clerk of Council, within three (3) years after service of notice of the passage of this resolution.

Section 4: In the event any such abutting property owner does not complete the construction of that portion of such sidewalks that abut his property in accordance with the plans and specifications and within the time prescribed, this Council will cause it to be done and the entire cost assessed on the property of the abutting property owner.

Section 5: The Clerk of Council is directed to serve notice of the passage of this resolution on the owners of the lots and lands abutting on the sidewalks as provided by law.

Section 6: That Council finds and declares that all formal actions concerning and relating to the adoption of this Resolution occurred in an open meeting of this Council or its committees, in compliance with law.

Section 7: That this resolution shall take effect and be in full force from and after the earliest period allowed by law.
