New Business

RESOLUTION 15-26, Squirrell moved that it be placed on first reading. Davies seconds. Approved by vote. Resolution 15-26, A Resolution authorizing the Board of Control to enter into an agreement and/or agreements with the State of Ohio Purchasing Cooperative, Department of Administrative Services, to purchase one (1) 2026 or newer Freightliner Dump Truck for the Service Department of the City of Orrville, Ohio; or alternatively to purchase said vehicle from another dealer upon equivalent terms, conditions, and specifications, but at a lower price than it can be purchased through the state contract, as allowed by Ohio Revised Code Section §125.04, and declaring an Emergency.

Discussion: Replacing a 25-year-old vehicle. Pricing is under the \$300,000 capital budget price. Requested approval tonight as they have a 2026 on the lot currently. This is through State Purchasing. Will try to trade in the old or auction it off.

Squirrell moved that the rules, regulations, and statutes requiring the reading of a resolution on three separate days be suspended. Carr seconded. Approved by vote. Squirrell moved that **Resolution 15-26** be adopted as read. Lax seconded. Approved by vote.
