ORDINANCE NO. B - 11

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF ORRVILLE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed and should be included in the Codified Ordinances of Orrville, Ohio;

WHEREAS, numerous sections of the Traffic and General Offenses Codes need to be updated in order to bring the City into compliance with State law;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ORRVILLE, STATE OF OHIO:

Section 1. That the editing, arrangement and numbering of those ordinances and resolutions enacted by Council from 1-4-10 to 1-3-11, as listed in the Comparative Section Table, are hereby approved and adopted as printed in the 2011 Replacement Pages, to the Codified Ordinances so as to achieve uniformity of style and classification. A copy of such Replacement Pages are attached to this ordinance and incorporated as a part thereof.

Section 2. That the following sections of the Traffic and General Offenses Codes, as reprinted and amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly:

That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of said City and for the further reason that it is necessary to update the City Codified Ordinances to reflect the legislation enacted by the State and City in the last year; therefore this ordinance shall be in full force and effect immediately after its passage and approval by the Mayor.


