ORDINANCE NO. C-16

An Ordinance approving the editing and inclusion of certain Ordinances as parts of the various Component Codes of the Codified Ordinances of Orrville, Ohio, and declaring an emergency.

WHEREAS, various ordinances of a general and permanent nature have been passed and should be included in the Codified Ordinances of Orrville, Ohio;

WHEREAS, numerous sections of the Traffic and General Offenses Codes need to be updated in order to bring the City into compliance with State law;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ORRVILLE, STATE OF OHIO:

Section 1: That the editing, arrangement and numbering of those Ordinances and Resolutions enacted by Council from January 1, 2015 to January 1, 2016, as listed in the Comparative Section Table, are hereby approved and adopted as printed in the 2016 Replacement Pages to the Codified Ordinances so as to achieve uniformity of style and classification. 
