Ordinance F-23

An Ordinance repealing and replacing Sections 144.01, 144.02, 144.03 and 144.04 of Chapter 144 of the Codified Ordinances of the City of Orrville, Ohio, relating to fees and use of revenues for fire, rescue and/emergency rescue and ambulance transport services and declaring an emergency. ^ and charging the title of Chapter 144

BE IT ORDAINED by the Council of the City of Orrville, Ohio:

That the title of Chapter 144 of the Codified Ordinances of the City of Orrville, Ohio shall be changed to: Fire, Rescue, and Emergency Rescue and Medical Ambulance Transport Services.

That Section 144.01 of Chapter 144 of the Codified Ordinances of the City Section 2: of Orrville, Ohio, shall be repealed and replaced as follows:

144.01 Fire, Emergency Medical and Rescue Service

To the extent that manpower and equipment are available, the Orrville Fire Department shall provide fire, rescue, and/or emergency medical and ambulance transport services in response to a call for such services within the City and outside of the City, under the provisions of applicable law for permitted mutual aid.

That Section 144.02 of Chapter 144 of the Codified Ordinances of the City **Section 3:** of Orrville, Ohio, shall be repealed and replaced as follows:

144.02 Fees

The Finance Department is hereby authorized to charge residents and nonresidents who receive fire, rescue, and/or emergency medical and ambulance transport services from the Orrville Fire Department.

That Section 144.03 of Chapter 144 of the Codified Ordinances of the City Section 4: of Orrville, Ohio, shall be repealed and replaced as follows:

144.03 Rules and Regulations

The Director of Safety and Service is hereby authorized and directed to establish rules and regulations for providing fire, rescue, and/or emergency medical and ambulance transport services and the collection of the fees provided for herein, including, but not limited to, the acceptance of third party assignments.

Section 5: That Section 144.04 of Chapter 144 of the Codified Ordinances of the City of Orrville, Ohio, shall be repealed and replaced as follows:

144.04 Use of Revenue

One hundred percent (100%) of the fees collected for each occurrence of a person or entity receiving fire services shall be deposited into the General Fund.

One hundred percent (100%) of the fees collected for each occurrence of a person or entity receiving rescue, emergency medical and ambulance transport services shall be deposited into one or more funds established by the Council for the purpose of personnel expenses, paramedic education and training, supplies, the acquisition of emergency medical service vehicle(s), equipment, and the payment of the cost of financing the same.

Section 6: This legislation is retroactive to January 1, 2023.

Section 7: All legislation inconsistent herewith is hereby repealed. Amended by council July 3, 2023
