	WHEREAS, Ohio Revised Code §3743.45, effective July 1, 2022, allows any person authorized to possess consumer grade 1.4G fireworks to discharge, ignite or explode consumer grade 1.4G fireworks on their property, or if permitted, on another person's property on certain designated days of the year; and							
	WHEREAS, pursuant to Home Rule authority, a municipal corporation may choose to restrict the dates and times that a person may discharge, ignite, or explode consumer grade 1.4G fireworks or may impose a complete ban on the use of consumer grade 1.4G fireworks; and							
	WHEREAS, this Council, with input from City fire and police departments, enacted Ordinance C-22, setting forth certain dates and times for the discharge of fireworks; and							
	WHEREAS, subsequent legislation from the State Fire Marshall was enacted in OAC §1301:7-7-56(Z)(5)(b)(5626.5.2) setting forth times that are inconsistent with Ordinance C-22.
