

**FAMILY WAIVER**

**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The City of Orrville, Ohio (“City”) has put in place preventative measures to attempt to reduce the spread of COVID-19 in compliance of directives and guidelines; however, the City cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, use of City facilities, including Orr Park and Orr Pool (“City Facilities”), could increase your risk and your child(ren)’s risk of contacting COVID-19. Further, the City has established certain rules and procedures for the use of City Facilities.

By signing this Agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 through the use of City Facilities, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at City Facilities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, City employees, volunteers, other City Facilities users and their families. I further acknowledge that I have read, understand and agree to comply with any and all rules and procedures established by the City for the use of City Facilities and that I have instructed my child(ren) regarding those same rules and procedures to ensure my child(ren)’s compliance with same.

I understand and agree that neither I nor my child(ren) will use City Facilities if any member of our household has a fever greater than 100 degrees, cough, shortness of breathing or difficulty breathing, new loss of taste or smell, has had contact or exposure to someone who has confirmed or presumptive COVID-19 within the last 14 days or exhibits any other sign or symptom of COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind (“Claims”), that I or my child(ren) may experience or incur in connection with my child(ren)’s use of City Facilities. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless the City, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the City, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after use of any City Facilities.
