RESOLUTION NO. 23-15

A Resolution Amending Resolution 15-15 and authorizing the Safety Service Director and the Board of Control of the City of Orrville, Ohio, to advertise for bids and to execute and participate in the Ohio Public Works Commission State Capital Improvement Program for loan funds and/or agreements as required to obtain said funds, and declaring an emergency.

WHEREAS, the Council of the City of Orrville, Ohio previously adopted Resolution 21-14 on June 2, 2014 which identified certain roads and streets that were included in the "2014 Concrete Street Improvement Project" and authorizing the Board of control to advertise for bids and enter into contracts for needed repairs and improvements to certain City streets; and

WHEREAS, bids were received in 2014 for certain streets that were not repaired or improved in 2014 due to funding constraints; and

WHEREAS, funding was secured for the completion of the improvements and repairs to Crown Hill Road, North Elm Street, Hostetler Road, West Market Street, East High and Church Street in 2015 ("2015 Concrete Street Improvements"); and

WHEREAS, the State Capital Improvements Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the City of Orrville, Ohio is planning to make capital improvements to Crown Hill Road, North Elm Street, Hostetler Road and West Market Street (2015 Concrete Street Improvements); and

WHEREAS, the infrastructure improvements hereinabove described are considered to be a priority need for the community and are qualified projects under the Ohio Public Works Commission programs; and

WHEREAS, the Council of the City of Orrville, Ohio previously adopted Resolution 15-15 on May 4, 2015 relating to the *contracting* for capital improvements to the 2015 Street Improvements. A request for authorization to *bid* for the improvements was inadvertently omitted from Resolution 15-15; and

WHEREAS, the Board of Control did in fact solicit and receive bids in 2015 prior to contracting for the 2015 Concrete Street Improvements; and

WHEREAS, the Board of Control desires to correct the oversight and ratify its actions in securing bids for the 2015 Concrete Street Improvements.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Orrville, Ohio:

Section 1: That the Board of Control is hereby authorized to advertise for bids and the prior actions of the Board of Control in securing bids for the 2015 Concrete Street Improvements are hereby accepted and ratified.


Section 2: That the Safety Service Director and/or Board of Control are hereby authorized to enter into any agreement and/or agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3: That upon passage of this amended Resolution, Resolution 15-15 shall be repealed.

Section 4: That this Resolution is hereby declared to be an emergency measure for the reason that capital improvements are essential to the functioning of the City; therefore, this Resolution shall be in full force and effect immediately after its passage and approval by the Mayor.
