## RESOLUTION 27-20

**A Resolution authorizing the Board of Control of the City of Orrville, Ohio, to enter into a contract with Kimble Recycling and Disposal, Inc., competitively bid by the City of Wooster, Ohio for refuse collection and disposal and curbside recycling services; and declaring an emergency.**

WHEREAS, Ohio Revised Code Section 9.48 permits a political subdivision to participate in a contract that another political subdivision has competitively bid for the "acquisition of equipment, materials, supplies, or services," and

WHEREAS, the current contract between the City of Orrville and Kimble Recycling and Disposal, Inc., for refuse collection and disposal and curbside recycling services will expire on December 31, 2020, making it necessary for the City of Orrville to obtain said services; and

WHEREAS, the City of Wooster has entered into a contract with Kimble Recycling and Disposal, Inc., for refuse collection and disposal and curbside recycling services with said contract having been competitively bid by the City of Wooster; and

WHEREAS, the City of Orrville has requested that it be permitted to participate in the contract with Kimble Recycling and Disposal, Inc., as entered into the by the City of Wooster; and

WHEREAS, the City of Wooster will permit the City of Orrville to participate in the contract which Wooster has entered into with Kimble Recycling and Disposal Inc.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Orrville, Ohio, that:

- Section 1: That the Mayor and Safety Service Director are hereby authorized to enter into a contract with Kimble Recycling and Disposal Inc., competitively bid through the City of Wooster, for refuse collection and disposal and curbside recycling services on the terms and conditions contained in the contract entered into by the City of Wooster, and on such further terms contained in the contract between the City of Wooster and Kimble Recycling and Disposal Inc., and the City of Orrville shall be responsible for payment for services to Kimble Recycling and Disposal Inc., directly;
- Section 2: That the rates set forth in the City of Wooster contract with Kimble Recycling and Disposal Inc., shall be the rates set forth in the contract between the City of Orrville and Kimble Recycling and Disposal Inc., and are as follows:
- 2021- \$15.02 per month per residence
  - 2022- \$15.47 per month per residence
  - 2023- \$15.95 per month per residence
  - 2024- \$16.60 per month per residence
  - 2025- \$17.20 per month per residence
- Section 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
