## Resolution 32-23

Section 5:

A Resolution establishing rates of pay for the Members of the Fire Department of the City of Orrville, on-call pay, and call-in; repealing conflicting Ordinances; and declaring an emergency.

BE IT RESOLVED by the Council of the City of Orrville, Ohio:

Section 1: <u>Wages:</u> That the class for members of the Fire Department shall be determined by the Fire Chief based upon job assignments and training and, the rate of pay of each class shall be as follows:

01	Meetings, training, work details, drills and all working time and new recruits while on probation period.	\$10.10
02	Firefighter with State of Ohio "Volunteer Firefighter" training for fire and EMS runs and Firefighters with Firefighter #1 and Firefighters #2 with no EMS Certification on EMS run.	\$14.08
03	Firefighter with State of Ohio "Firefighter I" training for fire runs and Foreman of Apparatus when performing technical maintenance on emergency vehicles and equipment.	\$17.60
04	Firefighter with State of Ohio "Firefighter II" training for fire runs.	\$17.60
05	EMT with "basic" training (EMT-A) while on EMS run.	\$19.36
06 ,	EMT with "advanced" training (EMT-I) while on EMS run	\$19.36
07	EMT with "paramedic" training (EMT-P) on EMS run	\$21.30 - \$23.43
08	Lieutenants on all emergency runs, Meetings, training, work details, drills.	\$25.77
09	Captains on all emergency runs, Meetings, training, work details, drills.	\$28.34
10	Assistant Chief of the Department on all emergency runs Meetings, training, work details, drills.	\$29.76
Section 2:	On Call Pay: Members of the Fire Department shall receive a \$25.00 shift payment for each shift that they are on call and required to respond to any EMS calls during that shift.	
Section 3:	<u>Call in Pay:</u> Members of the Fire Department required to respond to EMS calls during a scheduled on-call shift shall receive a minimum of two hours' pay at their normal rate of pay.	
Section 4:	That the compensation provided for herein shall become effective as of September 1, 2023.	

Section 6: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation for the public peace, health, safety, and general welfare of the City of Orrville, and for the further reason that maintaining and retaining qualified firefighters and EMT personnel is critical to the safety of the City of Orrville. Therefore, this Resolution shall be in full force and effect immediately after its passage by Council and approval by the Mayor.

All legislation inconsistent herewith is hereby repealed.
