

Resolution 4-24

A Resolution to establish the classifications of Fire Technician I – P/T, Fire Technician II – P/T, Fire Technician III – P/T, Fire Technician IV – P/T, Fire Lieutenant – P/T, Fire Captain – P/T, and Assistant Fire Chief – P/T unclassified service of the City of Orrville, Ohio, and repealing all legislation inconsistent herewith.

BE IT RESOLVED by the Council of the City of Orrville, Ohio:
