RESOLUTION 45-21

A Resolution establishing the salaries and wages of full-time employees of the City of Orrville for the grades heretofore established, repealing all legislation inconsistent herewith, and declaring an emergency.

Section 11: The respective employment authorities of the City of Orrville may pay a lesser amount than the amount provided for in the above pay grades as said employment authorities in their discretion may determine.

Section 12: A person whose current pay grade is higher than that provided for in this Resolution shall not receive a reduction in pay as a result of the adoption of this Resolution.

Section 13: That annually, effective January 1, 2021, the hourly wage rates for all classes within the Fire Department shall be adjusted at the same rate as the negotiated increase applicable to the United City Workers.

Section 14: That effective January 1, 2019, the pay ranges of employees in the classifications of Director of Finance, Director of Safety-Service, Director of Utilities, and Human Resources Manager, at the Mayor's and/or the Public Utility Board's discretion, as applicable, and with a satisfactory performance evaluation, may be adjusted up to the United City Worker's negotiated general wage increase.

Section 15: All legislation inconsistent herewith is hereby repealed.

Section 16: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of the City of Orrville, and for the further reason that it is necessary to comply with the labor contracts effective as of January 1, 2022. Therefore, this Resolution shall be in full force and effect immediately after its passage by Council and approval by the Mayor.
