Community Reinvestment Area (CRA) Residential Tax Incentives

If your property is located in the City of Orrville CRA District #1 (please see map), you may be eligible for a tax incentive through the City's CRA program in which you can receive 50% of the **NEW** property tax generated by this project forgiven for ten years. To qualify your remodeling project costs must be at least \$2,500 and increase the assessed value of your property. Examples of such projects are:

- Add a new front porch
- Install additional bathroom or toilet
- Finish attic or basement with paneling, plaster or plasterboard
- Add additional living area
- Add full house air conditioning
- Install indoor fireplace
- Build new or enlarged garage
- Add a shed over 120 square feet
- Add a deck over 25 square feet
- Add an in-ground swimming pool

To apply for this tax incentive, please complete the enclosed application and return it to me, along with documentation that your project costs exceeded \$2,500. It will be approved by the City of Orrville Housing Officer and forwarded to the County Auditor for processing.
