General Rules and Regulations

1. In order to insure reservations, schedules and requests must be received by May 1.
2. The western most tennis court may not be reserved for training, league play, or warmups, but must be held open for use by the general public. The southern most basketball court must be held open for the general public. Failure to do so may result in cancellation of the reservations or denial of future use by the offending organization.
3. Deposit and fee shall be paid to the City at least five days prior to tournament. Eighty percent (80%) of your deposit and fee will be refunded (or an alternate date chosen) if the date is canceled at least five days prior to the tournament.
4. There will be a \$100 tournament fee required, which includes a \$50 deposit (cash or check made payable to City of Orrville). A portion of or all of the \$50 deposit will be forfeited to the City without question if in the opinion of the Safety-Service Director any of the rules or regulations are broken or the court or park facilities are damaged in my manner. There will be a \$20 cancellation or rescheduling fee, except as outlined in #4 below.
5. If the court is deemed unplayable by the City due to rain, the sponsoring team's \$100 will be refunded or an alternate tournament date chosen. A lack of teams to play is not sufficient reason to cancel and your \$50 tournament fee will not be refunded.
6. The sponsor (or persons providing training or lessons) must be an Orrville-based resident or company. No sponsor may have more than two tournaments in any year.
7. The sponsor must agree to the following conditions:
 - a. No game shall begin before 9 a.m., Monday through Saturday, and 12 noon on Sunday. No game will start after 11:15 p.m.
 - b. The sponsor and/or sponsoring team hereby agrees to indemnify and hold the City harmless from any and all liability that may result from the event in questions.
 - c. Sponsor must notify all entrants of prohibition of alcohol in the park.
8. The City must specifically authorize any concession or vendors who wish to operate during the tournament or league play.
9. The Safety-Service Director, Service Department Superintendent, Park Manager, or Park Foreman may determine at any time if the court(s) is unplayable.
