RULES AND REGULATIONS

- A \$100.00 nonrefundable fee shall be paid to the City of Orrville at the time of reservation.
- If the field/court(s) is deemed unplayable by the City administration or authorized park staff due to rain, the sponsor's \$100 fee will be refunded or an alternate tournament date chosen. A lack of teams to play is insufficient reason to cancel and your \$100 fee will NOT be refunded.
- A copy of this form must be posted on the bulletin board at Orr Park main diamond during the tournament dates.
- After-hours and weekend diamond service will NOT be provided.

GENERAL RULES

The sponsor must be an Orrville-based resident or company. No sponsor may have more than two tournaments in any year. You must agree to the following conditions:

- Fill batter's box in, water and tamp after every game.
- Any holes on the infield that are forming must be filled in.
- No game shall begin before 9 a.m., Monday through Saturday, and 12 noon on Sunday. No game will start after 11:15 p.m.
- No warming up in the grassy area in upper park. Softball/baseball warm-up area is located east of the main diamond in the grassy area along the High Street parking lot.
- Sponsoring team must notify all entrants of prohibition of alcohol in the park.
- All sponsoring teams must be sanctioned by the ASA or USSSA providing insurance coverage, or the City must be provided with a \$1,000,000 liability policy naming the City as the insured.
- The western most tennis court (court 4) may not be reserved for training, league play, or warmups, but must be held open for use by the general public. The southern most basketball court must be held open for the general public. Failure to do so may result in cancellation of the reservations or denial of future use by the offending sponsor.

The City must specifically authorize any concession or vendors who wish to operate during the tournament or league play.

The City shall not be liable for any loss, damage, injury or illness incurred by any user of the location. I understand that I am responsible for any and all damages caused by my/our use of the ball field, bleachers, dugouts, or any other location as listed above and that I will be invoiced by the City of Orrville for any damages that occur.
