New Business

Ordinance E-21 Lorson moved that it be placed on first reading. Mosley seconded. Roll call vote; all yeas; motion carried. <u>Ordinance E-21</u>, An Ordinance authorizing the Mayor, President of Council, and Director of Finance to enter into an Agreement with the Regional Council of Governments for the administration of the Income Tax Laws and collection of taxes for the City of Orrville, Ohio through the Regional Income Tax Agency and declaring an emergency.

Discussion: Our income tax employee, Dave Nussbaum, is going to retire soon. This is the best way to move forward with the complexity of state mandates for revenue collection, and due to COVID. The state has made comment that there is a possibility they could take over the tax collection. We feel a regional council of government with RITA is best. Brian Thunberg from RITA was present to go over their services and answer questions including ease for residents, reviewing our ordinances when state or federal changes are made, revenue projections, unpaid tax collections, hours for call-ins, and customer service. This will go to second reading. November 1, 2021
