Parks and Recreation – Handwerk: Update on projects – fields 1 & 2 have LED lights installed, new restroom, batting cage, culverts/bridges, and the new splash pad opened. Upcoming is a skate park day July 16. Community Day is August 6.

Health & Safety: Trash is on a one-day delay due to the holiday.

Administrative Reports

Mayor Dave Handwerk: Regarding the park projects, complimented Mr. Wheeler, his department, Dan Lowe with the work and coordinating contractors and the extra work for our Service Department.

Safety-Service Director Steve Wheeler: This Thursday, Orrville Performing Arts presents The Three Baers. The spray park is open with hours of 9 am- 9 pm this summer. Recognized Dan Lowe, Ryan Immel, Mike Ammon and the entire Service Department to meet the July 1st deadline on the spray park. It was a great 4th of July week as well as the tournament the week prior. Special thanks to Chief Bishop, Assistant Chief Ballentine, entire fire department, all the volunteers, former Chief Ballentine, Councilman Shanklin for their commitment and time. As well as the Police and Service Departments for their efforts as well.

Mayor: Talking about the park and all the use it has had, we had two weekends in a row with large tournaments and this weekend with the youth baseball tournament.

Utility Director Jeff Brediger: A recent Supreme Court ruling reversed some EPA actions that regulates greenhouse gas emissions from power plants. The court ruled the EPA didn't have that authority for those directives because they resulted in substantial, monumental policy with a big economic impact. A draft ordinance and slide presentation was distributed with regards to an upcoming solar project coming before council at the next meeting.

Finance Director Janet Strimlan: 2023 Budget is on second reading tonight with third reading on July 18 with approval needed that evening to meet the county's deadline for submission. The finance department is busy working on the annual audit for 2021.

Council President Paul Vance: Regarding the park projects, took his grandson to the park and he approved. Many families using the ZipKrooz and the splash pad. Thanks to everybody.
